- 2) Application and payment are due by June 28, 2022. Applications and payments received after said date will be charged a \$25 late fee. No refunds.
- 3) You must be available to attend both days of our event. Cleaning up/leaving the festival early may result in a denied application for 2023.

- 4) Tents/Canopies must stay inside of your space and cannot obstruct the walkways. Canopies/Tents are required to have weights- stakes are prohibited. Electrical equipment, supplies, water hook-ups, etc. are not provided.
- 5) Spaces will be assigned only after the application has been approved by the WPCA Board and is done on a first-come-first-served basis. Location will be assigned by the committee.

Approved Vendors will be notified of their booth space number(s) with regulations and a map a week prior to the event date.

- 6) Vendor agrees to indemnify, defend and hold harmless, WPCA, the Village of White Pigeon, and White Pigeon Days 2022, from and against any and all loss, damage, claim for damage, liability, expense or cost, including attorney's fees, which arises out of, or is related to, or is in any manner connected with the Vendor's participation in White Pigeon Days 2022. This indemnification provision shall apply to any acts or omissions, willful misconduct, whether active or passive, on the part of the Vendor or of anyone employed by or working for the Vendor.
