- 5) Spaces will be assigned only after the application has been approved by the WPCA Board and is done on a first-come-first-served basis. Location will be assigned by the committee. Approved Vendors will be notified of their booth space number(s) with regulations and a map prior to the event date by request only.
- 6) Vendor agrees to indemnify, defend and hold harmless, WPCA, the Village of White Pigeon, and White Pigeon Days 2024, from and against any and all loss, damage, claim for damage, liability, expense or cost, including attorney's fees, which arises out of, or is related to, or is in any manner connected with the Vendor's participation in White Pigeon Days 2024. This indemnification provision shall apply to any acts or omissions, willful misconduct, whether active or passive, on the part of the Vendor or of anyone employed by or working for the Vendor.
